3. You will also have to lodge a Street Trader Form to the Mt Alexander Shire ASAP for all Food and drinks
4. Current Public Risk Insurance Policy should be forwarded with your fee, to us as well. No In door Space is available. You will need to supply your own Electrical Leads/Lights and trestles.
